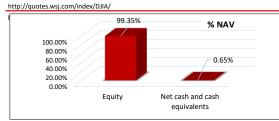


## Goals of the Fund

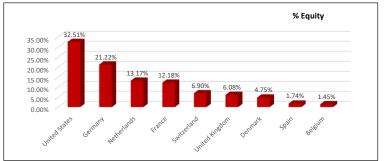

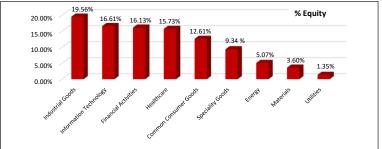

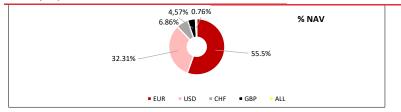




Sectoral Exposure
